FPPA Summary of Benefits

Current paid benefit is \$250/month

GVFPD benefit plan is for members who provide 10 years of service

- Member must maintain a minimum of training participation of 36 hours
- Paid benefit at age 50

Retired firefighter who returns to active service

- Eligible to serve as an active member
- Continues to receive pension
- Do not receive any additional service credit for the purpose of increasing benefit

Service Accrual – Vested

- Minimum time that must be worked for each department is 5 years in order to accrue a “vested” retirement. After 5 years, if member leaves, they are considered a “terminated vested member.”

Survivor Benefit – for death of a retired firefighter

- Death regardless of age, firefighter has served 20 years, and leaves a surviving spouse – benefit pays 50% of normal retirement until remarriage or death

Funeral Benefit

- When an active volunteer or retired fire department member dies, the board must pay a funeral benefit to assist in the proper burial of the deceased firefighter. The fund may not pay more than twice the amount of the normal retirement benefit, but not less than \$100
