Re: Briefing materials for August 1 work session

Date: August 1, 2022

The purpose of this memo is to provide briefing materials to help guide and support discussion at the August 1 work session. The CWPP implementation committee (temporary name, a new name may be needed) met on July 27 and refined these materials, as well as discussed expectations for this work session. The committee understands that it may take multiple work sessions or other discussions with the board to reach a strong consensus on specific implementation actions. We also understand that the board cannot make official decisions during a work session but we hope that the board will give input and guidance that we can use to develop specific proposals for board consideration in the future.

The committee has four specific expectations of outcomes from this work session.

- Input and support for the two-track implementation strategy for 2022-2023
- Input on the concept of a resolution to officially begin the program and what should be included in a resolution.
- Input on location of the new program within the district organization
- Support to begin planning major programs for implementation in 2023 that are recommended in the CWPP: ambassador, chipping, roadway mitigation and evacuation drills

## **CWPP Implementation Tracks for 2022-2023**

## From Evergreen evaluation study

**Go slow to go fast.** "While we very clearly understand the sense of immediacy, developing programs without a strategy or without the needed capacity will lead to poor results and ultimately the failure of the program. Take the time to thoughtfully consider program design and give the people in leadership roles the time they need to do just that."

### **Strategic**

- Formally establish the overall program for the future. Resolution
- Location in district organization
- Funding and grant strategies
- Long-term mitigation plan and priorities
- Engage with HOAs, including roadway and open space mitigation
- Engage with USFS and other organizations on larger mitigation projects such as CPRW and NCFS
- Engage with USFS on mitigation on USFS lands within district
- Develop major programs for implementation in mid-2023, ambassador, chipping, roadway mitigation, evacuation drills
- Future staff needs

## Tactical (2022 Firewise and 2023 budget)

- Determine status of Firewise designation
- Improve website and other educational information
- Promote residential defensible space and home hardening
- Training and network opportunities for committee
- Winter special newsletter
- Develop slash strategy/options, maybe seminar in cooperation with DU
- Support current mitigation projects by collaborating organizations, HOAs, ad-hoc groups and residents including support of grant applications
- Recognize on-going mitigation efforts and success stories, demonstration projects
- Identify and plan first major mitigation project for 2023

# RESOLUTION TO ESTABLISH A WILDFIRE RISK REDUCTION PROGRAM AND IMPLEMENT A COMMUNITY WILDFIRE PROTECTION PLAN

A RESOLUTION establishing a wildfire risk reduction program.

**Whereas**, the Glacier View Fire Protection District is located within the identified high risk Wildland Urban Interface area as designated by the Larimer County Hazard Mitigation, and

Whereas, the Glacier View Fire Protection District and its residents have suffered significant losses due to wildfires, and

**Whereas**, the Glacier View Fire Protection District has produced and approved a Community Wildfire Protection Plan in accordance with requirements of the Colorado State Forest Service.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE GLACIER VIEW FIRE PROTECTION DISTRICT, LARIMER COUNTY, COLORADO:

**Section 1:** Establish a wildfire risk reduction program under the strategic umbrella of Fire Adapted Communities including maintaining designation as a Firewise Community, and

**Section 2:** Establish a standing CWPP Implementation Committee with members from the GVFPD membership, community members, representatives of home owner associations and other organized groups within the district to plan and implement actions focusing on prevention, safety & evacuation, resident mitigation, partnerships & community engagement and landscape treatment.

Section 3: Assign a Board member to the CWPP Implementation Committee as liaison to the board, and

**Section 4:** Establish a finance system under the district budget reflecting revenues and expenditures, and

**Section 5:** Where in current organization?
